Part Two:

Synoptic Situation	The off-shore trough at mean sea level now runs along south Gujarat – north Kerala coasts. The shear zone now runs roughly along 18°N at 5.8 km above mean sea level. The cyclonic circulation over Kutch extending upto 1.5 km above mean sea level tilting southwestwards with height has become less marked. Southwest Monsoon strong over Westcentral and southwest Arabian sea, moderate to strong over Eastcentral, Northeast Arabian Sea, Moderate over Northwest and weak to moderate over Southeast Arabian Sea.

North East Arabian Sea:

Wind	Southwesterly to Westerly 20 to 25 knots gusting to 30 knots.
Weather	Isolated rain or thundershowers.
Visibility	Good except in rain or thundershowers.
Sea Condition	Moderate.

North West Arabian Sea:

Wind	Mainly Southwesterly 15 to 20 knots gusting to 25 knots.
Weather	Isolated rain or thundershowers.
Visibility	Good except in rain or thundershowers.
Sea Condition	Moderate.

East Central Arabian Sea:

Wind	Southwesterly to Westerly 20 to 25 knots gusting to 30 knots.
Weather	Widespread rain or thundershowers with isolated squall.
Visibility	Moderate becoming poor in rain or thundershowers and very poor in squall.
Sea Condition	Moderate to Rough.

West Central Arabian Sea:

Wind	Mainly Southwesterly 25 to 30 knots gusting to 35 knots.
Weather	Isolated rain or thundershowers.
Visibility	Good except in rain or thundershowers.
Sea Condition	Rough to very rough.

South East Arabian Sea: (West of 72 deg E)

Wind	Southwesterly to Westerly 10 to 15 knots gusting to 20 knots.
Weather	Fairly Widespread rain or thundershowers with isolated squall.
Visibility	Moderate becoming poor in rain or thundershowers and very poor in squall.
Sea Condition	Moderate.

South East Arabian Sea: (East of 72 deg E)

Wind	Westerly to Northwesterly 10 to 15 knots gusting to 20 knots.
Weather	Widespread rain or thundershowers with isolated squall.
Visibility	Moderate becoming poor in rain or thundershowers and very poor in squall.
Sea Condition	Moderate.

South West Arabian Sea :

Wind	Mainly Southwesterly 25 to 30 knots gusting to 35 knots.
Weather	Scattered rain or thundershowers.
Visibility	Good becoming poor in rain or thundershowers.
Sea Condition	Rough to very rough.

Lakshadweep Area:

Wind	Southwesterly to Westerly 15 to 20 knots gusting to 25 knots.
Weather	Fairly Widespread rain or thundershowers with isolated squall.
Visibility	Moderate becoming poor in rain or thundershowers and very poor in squall.
